**BIO:** Dick Honneywell is currently director of the of the UAS center and test complex. He is responsible for aerospace business development and expansion in the Dayton region and State of Ohio. He leads implementation of initiatives including development of Unmanned Air Vehicles (UAV) infrastructure, supply chain consolidation and expansion of maintenance, and repairs & overhaul (MRO) capabilities. He also focuses on identification, facilitation and implementation of technology-related opportunities in materials, structures, propulsion, power systems and sensors which enable aviation growth.

Dick retired from civil service with over 32 years of service in support of the United States Air Force in April 2011. His last duty position was serving as the Director of Nuclear Surety, HQ AFMC at Wright Patterson AFB. He retired as Colonel from the Air Force Reserve with 30 years of service in January 2009. He has held numerous acquisition management positions in the Air Force Research Laboratory, Aeronautical Systems Center, Electronic Systems Center and HQ Air Force Materiel Command.

Dick graduated in December 1978 from Arizona State University with a Bachelor of Science Degree in Mechanical Engineering and was commissioned into the Air Force. He earned a Master's of Science in Engineering Management in 1987 from the University of Dayton and graduated from the Defense Leadership and Management Program in 2008. Dick is a member of the Air Force Association and the Armed Forces Communications and Electronics Association (AFCEA).
