# 12:25 <u>Featured Speaker</u>: Brian Pollock, Chief of Program Support for the 711<sup>th</sup> Human Performance Wing (Nadja Turek)

Mr. Pollock's presentation will focus on the United States Air Force School of Aerospace Medicine's mission of training flight nurses and aeromedical evacuation personnel to include the acquisition of C-17 and C-130H fuselages to be converted to training platforms and the associated facility projects to support the effort.

As the Senior Acquisition Official for the wing, his duties include managing the contractual requirements analysis, development, and life-cycle execution for services (A&AS) and products (consumables) needed to support the research, education and consultation missions of the wing.

He is a retired, prior-enlisted, Air Force Civil Engineering Major, whose assignments included Scott, Moody, Elmendorf twice, Clear, Whiteman, and Wright-Patterson 3 times. Including deployments to Korea, Saudi Arabia and Guam. After retiring from the Air Force in 2005, he spent 5 years as a contractor working for Concurrent Technology Corporation managing pollution prevention and alternative fuel projects for AFRL. After 3 years working Acquisition Environmental issues for ASC and the F-35 program, he joined the 711th in Dec 2012 as the Chief of Facilities and assumed his present duties in June of 2014. He earned his Bachelor's degree in Industrial Engineering from the University of Illinois in 1988 and received his Master's in Engineering and Environmental Management from AFIT in 1996. Mr. Pollock has been a member of SAME for 26 years.
